I hereby make application to **Cruisin' Safely Motorcycle & Driving Instruction, LLC.**

_____ I agree to pay a fee of \$330 for a complete course of driving instruction including 30 hours of classroom instruction, 6 hours car observation and 6 hours behind-the-wheel instruction. Payment of \$165 is due before classroom instruction and the balance of \$165 is due when receiving the MV3001 form necessary to obtain a temporary driving permit for behind-the-wheel instruction. The Department of Motor Vehicles Motorist Handbook will be provided as part of the fee. Students will retain their copy of this handbook. Drive Right Revised 10th Edition will be provided for use during the course, but will be returned to Cruisin' Safely upon completion of the course.

_____ I agree to pay \$40 for damaged or non-returned Drive Right textbook.

_____ I agree to pay a fee of \$100 for 30 hours of **classroom** instruction only.

_____ I agree to pay a fee of \$250 for 12 hours of **behind-the-wheel** instruction only.

_____ Additional classroom instruction - \$25 per hour.

_____ Additional behind-the-wheel instruction - \$45 per hour.

Students that miss scheduled appointments will be charged \$30 per hour for make up. If a student finds it necessary to reschedule an appointment, a 48-hour cancellation notice is required.

The school will not refund any tuition if the school is ready, willing and able to fulfill its part of the agreement.

The school is designed to enhance traffic safety education and does not guarantee anyone a Wisconsin driver's license.

This agreement constitutes entire contact between the school and the student and no verbal statement or promise will be recognized.
